For the period from 16 March 2025 to 31 May 2025

1. About the Organization

Amid the prevailing politics of criminalization, the political economy of corruption, and the entrenched power structure in Bangladesh, a foundation of fascism was established—where values such as human dignity, social justice, and the rule of law were reduced to mere rhetoric. Though the oppressive system was toppled through the people's and students' blood-stained uprising in July, the full realization of human dignity, economic freedom, justice, and fairness has yet to be achieved.

United Peoples Bangladesh (UP Bangladesh) is committed to uprooting the fascist structures and the entrenched culture of political criminalization in order to build an equitable and prosperous new Bangladesh.

As a political initiative born out of the July Uprising, **United Peoples Bangladesh (UP Bangladesh)** aims for a qualitative transformation in politics. Rooted in a Centre-Right political ideology, its mission is to transform the July Uprising into a full-fledged revolution. Inspired by the spirit and legacy of the blood-drenched July, UP Bangladesh is committed to uprooting fascism in Bangladesh, challenging hegemonic forces, transforming the current political culture, and establishing a healthy and sustainable democratic practice—from internal party structures to the overall state framework.

The platform began its efforts to unite the people on March 16, 2025, and officially launched its Central Committee on May 9, 2025, at the Central Shaheed Minar. From that historic venue, the platform declared a single, resolute demand — the resignation of fascist Hasina.

We firmly believe in zero tolerance against corruption and will always raise a strong voice in favor of religious faith and values, standing firmly against religious hatred.

UP Bangladesh is steadfast in its commitment to internal democratic processes and economic transparency within the organization. This platform pledges to liberate Bangladesh from four destructive forces: fascism, hegemony, religious hatred, and corruption. The July Uprising movement declares its resolve to build a new Bangladesh free from these evils.

2.1 Basis of Preparation of Financial Statement

The basis of preparation for the receipts and payments involves systematically recording all donations with receipts and bank statements, ensuring transparency and accountability. Expenses are categorized by activity type, such as program implementation, platform launch, fixed asset purchase, office advance and rent etc and supported by invoices. Cash and bank balances are reconciled to ensure accuracy and in alignment with the platform's objectives. UP Bangladesh prepared the statement of on a cash basis as it appeared appropriate for the nature of the operation.

2.2 Functional and presentation currency

These financial statements are presented in BDT (Bangladesh Taka), which is the program's functional currency. Unless otherwise specified, all figures have been rounded to the nearest BDT.

2.3 Reporting Period

These financial statements cover the reporting period from March 16, 2025 to May 31, 2025.
